Thank you Laurel VE test team for a job well done at the April 6 Amateur radio VE test session in Gaithersburg, MD. The test session was offered to Montgomery County area applicants who recently completed the Montgomery Amateur Radio Club (MARC) Spring "General License" upgrade course and other applicants interested in taking part in the test session.

The Laurel team tested 13 people at the Gaithersburg session, issued 21 test elements resulting in 6 new or upgraded licenses as well as 6 CSCE's. The highlight of the session was the "Grand Slam" by an applicant who went from zero to Extra (with no seat belts!) by passing all 4 test elements at the Gaithersburg session. We are proud of all stepped up to the plate!

A husband/wife couple from the MARC General class obtained their Technician license at the March LARC test session in Laurel and rumor has it, bought a house in Laurel, and joined the Laurel club!

These two LARC test sessions resulted in a total of 8 MARC class participants so far who have earned a new license or upgrade and 6 who have earned CSCE's in addition to or instead of new or upgraded tickets. More of the 35 MARC "General License" course enrollees are expected to test with Laurel or other VE teams in the near future.

FCC Enforcement Letters ...

RE: Amateur Radio license W----: Advisory Notice-Repeater Operations; Case #---

Dear Mr. Finley:

Information before the Commission indicates that you operate four uncoordinated repeater stations in North Carolina and one in Virginia, and that at least one of those repeaters has been moved twice, resulting in interference to a repeater system that is coordinated.

This letter is to advise you that Section 97.205 of the Commission's rules, 47 C.F.R. § 97.205, states that where there is interference between a coordinated and an uncoordinated repeater, "the licensee of the uncoordinated repeater has primary responsibility to resolve the interference". The Commission relies upon the repeater coordination process to help alleviate interference between repeaters and lessen the burden upon Commission resources required to resolve such problems. While the coordination process is voluntary, as long as your repeaters are uncoordinated, you will have the primary burden of resolving any interference that they cause to coordinated repeaters.

RE: Amateur Radio license K-----; Applications for Administrative Update; Case #-----

Dear Mr. McCloskey:

Since December 27, 2005, you have filed 61 applications for administrative update to your license records in our database. The Wireless Telecommunications Bureau has referred these applications to this office for review.

Until we receive a satisfactory explanation of what you are attempting to accomplish, no further applications will be accepted. The following applications will remain pending but will not be considered until this matter is resolved: 0002533947, 2532480, 2531572, 2531574, 2531576, 2531265, 2531264, 2531261, 2531260 and 2531257.
